Land Use Permits: Update meeting scheduled at County for Werth CUP. Looked over proposed Ordinance changes at County level.

Update on Roads: have about \$250k in budget plus ARPA funds, need to work on getting bids out for road work, looking for a 2nd ditch mower, would like it to be done 2xs a year. Spoke with Keith Nemmitz he would be interested in mowing part of White Clover Rd. Henschel to contact Bear Creek Board regarding Symco Rd

Public Comments/Communications: Troiber's reached out to see when Fire Number will be installed. Work has been done.
