

RESOLUTION 2025-1

TO DISCONTINUE ROAD 30 IN THE TOWN OF UNION, WAUPACA COUNTY

WHEREAS, It is proposed that the public interest requires that Road 30 be vacated; and.

WHEREAS, it is the purpose of this Resolution to state the intent of the Board to vacate and discontinue Road 30 as described above and particularly described below.

NOW THEREFORE, BE IT RESOLVED, by the Board of the Town of Union, Wisconsin:

Section 1. That the Board of the Town of Union, Wisconsin, hereby proposes to determine whether the public interest requires that Road 30, Town of Union, Waupaca County, Wisconsin, as hereinafter described, is to be vacated and discontinued pursuant to §66.1003 of the Wisconsin Statutes.

Legal Description of Discontinued Town Road Number 30

A part of the Northwest 1/4 of the Southeast 1/4 and part of the Northeast 1/4 of the Southwest 1/4 of Section 9, Township 24 North, Range 13 East, Town of Union, Waupaca County, Wisconsin is described as follows:

Commencing at the West 1/4 corner of said Section 9; Thence North 89°57'02" East along the North line of the Northeast 1/4 of the Southwest 1/4, 2397.80 feet; Thence South 00°02'58" East, 33.00 feet to the South right-of-way line of County Road "OO" prior to the Waupaca County right-of-way plat on file at the Waupaca County Property Lister Office and the point of beginning; Thence North 89°57'02" East along said South right-of-way line, 173.67 feet to the East right-of-way line of Town Road Number 30 and the beginning of a curve to the right; Thence along the arc of said curve 224.11 feet, said curve having a radius of 261.50 feet a central angle of 49°06'09" a chord that bears South 23°52'55" East for a distance of 217.31 feet; Thence South 00°40'10" West along said East right-of-way line, 369.98 feet to the West right-of-way line of State Road "110" and the beginning of a curve to the left; Thence along the arc of said curve 288.92 feet, said curve having a radius of 931.18 feet a central angle of 17°46'39" a chord that bears South 13°55'41" West for a distance of 287.76 feet to the West right-of-way line of Town Road Number 30; Thence North 00°40'10" East along said West right-of-way line, 650.08 feet to the beginning of a curve to the left; Thence along the arc of said 309.54 feet, said curve having a radius of 195.50 feet a central angle of 90°43'08" and a chord that bears North 44°41'24" West for a distance of 278.21 feet to the South right-of-way line of County Road "OO" prior to the said filed County Road right-of-way plat and the point of beginning.

Section 2. That the Town of Union be authorized and directed to give notice required by §66.1003 of the Wisconsin Statutes; and,

Section 3. That according to §80.32 of the Wisconsin Statutes, upon vacation and discontinuance of said Road 30, title to the above-described land shall belong to the adjoining property owner(s) to the north and south shown on the Exhibit "A", and,

Section 4. That this Resolution shall be in full force and effect immediately upon its passage and adoption.
